SC Conference Information on Video Recording and Video Consent and Release Forms

This document contains both the policy for video recording and the release forms required for all subjects.

SC Conference Session Video Recording

As long as the video policy is clearly and prominently posted outside (and inside) the meeting rooms, audience members will have sufficient notice about video recording: "This session is being video-recorded. By attending this session, you acknowledge that your image and comments may be recorded and re-broadcast."

It is also recommended that the following notice be included in registration materials, as well as collateral materials: "Sessions of SCxy may be video-recorded, and video recordings may be made in general sessions and common areas as well. By registering to attend SCxy, you are granting SC permission to record your image, comments, and questions during sessions."

SCxy may require the virtual dissemination of live or pre-recorded content. Any presenters of content that SCxy chooses to broadcast virtually will be notified of the requirement to record and possibly rebroadcast to registered attendees or participants any sessions and session materials SCxy chooses.
